Draft Minutes of the Parish Council Meeting held on Monday 7 January 2020

Public Comment: A member of the public showed the council photos of an unknown person taking pictures within the driveways of houses in St Michael's View. This has been reported to the police and video footage will also be provided to them. Residents are advised to be wary.

Mr R Bishop has written to SNDC Planning regarding numerous instances of non-compliance with planning permissions by Tas Valley Mushrooms and has had a response from the Deputy Director of Planning. He has sent these documents to the clerk and wishes to know if the council intend to follow this up. The clerk had circulated these documents to all councillors. The council have now asked the clerk to draft a letter to SNDC Planning to support Mr Bishop's views, in particular with regard to the failure to remove the bund around the site, the lack of progress on surface drainage, and the erection of ironwork above ground level. He will also comment on the fact that the temporary building put up as family accommodation pending completion of repair work on Mr Tumov's dwelling is still in place even though the main house has now been re-occupied.

County Councillor's Report: none

District Councillor's Report:

Cllr Legg informed the council that the new Greater Norwich Local Plan (GNLP) was published yesterday. There will be a presentation on 23 January at South Norfolk House and the public consultation period will run from 29 January. The initial phase of the GNLP does not include smaller rural communities, but a second phase will include smaller communities grouped into "clusters", which have been arranged in an attempt to maintain the viability of rural schools. The new GNLP should allow for small residential developments within rural communities, which are not permitted under the current Local Plan.

Cllr Clifford-Jackson has sent the clerk information on the Community Action Fund and the Members' Fund and these have been circulated to all councillors. She also informed the council that the Sunday bus service along the B1113, which was to be axed, has been given a reprieve.
