District Councillors' Reports:

District Cllr Legg informed the council that

- Newly acquired Horizon House they are looking into a new heating system, which will delay the move.
- The SNDC portion of the Council Tax will probably remain the same.
- There is now a consultation on the Local Plan (Village Clusters).
- The Bracon Ash solar farm will now have access on Long Lane.
- There is nothing new to report on Tas Valley Mushrooms.

District Cllr Francis told the council that

- police presence has increased, with five officers now in the area.
- The District Council will need staff to attend the office on a rota, to allow for redsuced parking and facilities.

District Cllr Spratt discussed the following:

- National Grid are well aware of the onshore vs offashore debate and people's concerns about this. Graham Stewart MP has said that there "remains an open and fair planning process". The second consultation will take place April-June 2023.
- Battery storage facility, planned to cater for future wind power developments, has been approved.
- A Public Space Protection Order is to be applied for because of increased vehicle-based antisocial behaviour.
- No sign yet of the report on Mrs London's development delayed because of unresolved issues around Nutrient Neutrality.
