District Councillors' Reports: District Cllr Legg confirmed that the move to shared admin accommodation for South Norfolk and Broadland Councils is to go ahead; it will take some time to equip the premises. Meanwhile, Cygnet House at Long Stratton is on the market. On Nutrient Neutrality, Cllr Legg informed the council that, based on advice from Natural England, planning g applications involving overnight accommodation, and sewage treatment plants, will be delayed. Seasonal ditches are no longer to be used to dispose of waste water. Members' ward grants are available for small community projects, with a deadline in December 2022.

A new policy document on planning enforcement is under preparation.

District Cllr Spratt introduced himself to the meeting and informed the council that District Councillors have guidance on bid writing and can assist in this if needed. Cllr Spratt confirmed that SNDC have written a letter of objection to National Grid over their proposed pylons from Norwich to Tilbury; this is to be followed up via Parliament.
