a 2020/1920 Mrs London's revised development plan: Mrs London has responded to a letter addressing concerns over flooding and effluent leakage on The Street, and is also working to improve ecology issues following an unfavourable ecology report.

object in principle but feel that a six-foot fence was excessively high and would dominate; clerk will respond accordingly
